YMCA Code of Conduct

The Fond du Lac Family YMCA is founded on Christian principles and asks its members and guests to act in a manner that upholds its core values of **Caring, Honesty, Respect, and Responsibility** at all times when they are on our property or participating in our programs.

We expect those using the YMCA to behave in a way that demonstrates a caring and respectful attitude and to behave in a mature and responsible way. The YMCA has implemented the following Code of Conduct to ensure that all individuals enjoy a safe, welcoming and comfortable environment. Actions not adhering to these guidelines are not permitted:

- Membership cards must be presented at the member service counter each time you enter.
- All YMCA policies and rules must be obeyed at all times.
- Inappropriate or negligent use of exercise equipment or destruction of property is not allowed.
- Attire must be appropriate for the activity and adequately cover the body.
- Swimsuits are only to be worn in the pool area. Bare feet and wet swimsuits are not allowed outside of the locker rooms or pool area.
- Clothing must not convey any vulgar or profane writing or pictures.
- Using angry or vulgar language, including swearing, name-calling or shouting, will not be tolerated.
- Having physical contact with a person in an angry or threatening way is not allowed.
- Engaging in sexual activity or contact with another person is not permitted at any time.
- Harassing or intimidating by words, gestures, body language or any other menacing behavior is not acceptable.
- Stealing or other inappropriate behavior will not be tolerated.
- Carrying or concealing any weapons, devices, or objects which may be used as a weapon is strictly prohibited.
- The sale, possession, distribution, use or being under the influence of any illegal substance or alcohol is prohibited in YMCA facilities or surrounding properties and will constitute grounds for immediate termination and possible prosecution.
- No smoking. All YMCA facilities and surrounding properties offer a smoke-free environment.
- Cell phone use and cameras of any kind are not allowed in the locker rooms.
- In order to carry out these policies, members and guests are to identify themselves to staff when asked.
- Any other conduct deemed inappropriate, threatening or offensive in nature is not permitted.

Members are encouraged to be responsible for their personal conduct and safety and to ask any person whose behavior threatens their personal comfort to refrain from doing so. Members and guests should notify a staff person if assistance is needed. A Manager on Duty and/or First Responder is available during normal hours of operation. The YMCA management staff will investigate all reported incidents. Suspension or termination of YMCA membership and privileges may result from any violation of the Code of Conduct. Reimbursement for membership and program fees will not be provided in the case of suspension or termination.
