Dear Valued Y member,

Due to the [Safer at Home Order](#) by Governor Evers issued on March 24, 2020, the Fond du Lac Family YMCA will continue to remain closed until Friday, April 24th, with no scheduled reopen date, or until a superseding order is issued. Secretary-designee Andrea Palm's Emergency Order #6 remains in effect and our Child Care Center will remain open, with prioritized care for families in our community. We will continue to support our community the best way we can, and right now this means supporting staff working in health care and other vital areas as deemed necessary by this order. We are one of [25 YMCA's across Wisconsin/U.P. Michigan](#) that is collaborating with local government and health officials to offer care for children of essential employees who need to work, because they directly support the efforts to mitigate the impact the coronavirus has in our communities.

We continue to ask you to stay with us so we can help support our community, our neighbors and our friends who are working during this epidemic, and that includes our amazing Child Care staff. Staying with us ensures our Y can continue to help support those who need us most.
